Glenway's Babysitting Services

The Junior-Child membership plan includes:

- Two hours of free child care per day, per club visit for parents/guardians of children with this plan. (Visits exceeding the 2 hour limit will be billed at Glenway's regular babysitting rate of \$4/hour or \$1/15 minutes) There is a 3 hour babysitting limit (exception for golf package-see below).
- Free use of Glenway's outdoor swimming pool and junior locker rooms. Up to 30% in savings off selected Junior programs; such as summer camps, martial arts programs and more.
- The Junior-Child membership can be paid for along with your regular pre-authorized monthly membership payment plans; or save 5% if paid annually.
- A Summer Junior-Child membership will be available this summer for the months of June, July and August, which will include use of the outdoor pool and junior locker rooms, but not free babysitting. Rate to be determined.

The Golfer Package includes:

- Two hours of free child care per day, per club visit for parents/guardians of children with a Junior-Child Membership. (Visits exceeding the 2 hour limit will be billed at Glenway's regular babysitting rate of \$1/15 minutes or \$4/hour)
- With this package, golfers can take advantage of a 4 1/2 hour babysitting limit, which may be booked 3 days in advance. Visits exceeding the 4 1/2 hour babysitting limit are NOT permitted (a \$20 fee will apply)
- **Pro Shop must be advised of babysitting when tee time is booked.**
- **Babysitting must be advised of tee time when booking babysitting.**
- Parents/guardians **must** check on their child(ren) before playing the 10th hole. Parents must register at the Pro Shop before proceeding to the 10th hole.
- Advanced booking is required for all babysitting sessions. For the golfer's packages specifically, member must give at least 24 hours notice of cancellations otherwise there will be an \$8 fee per child for no shows that were booked for the designated times.

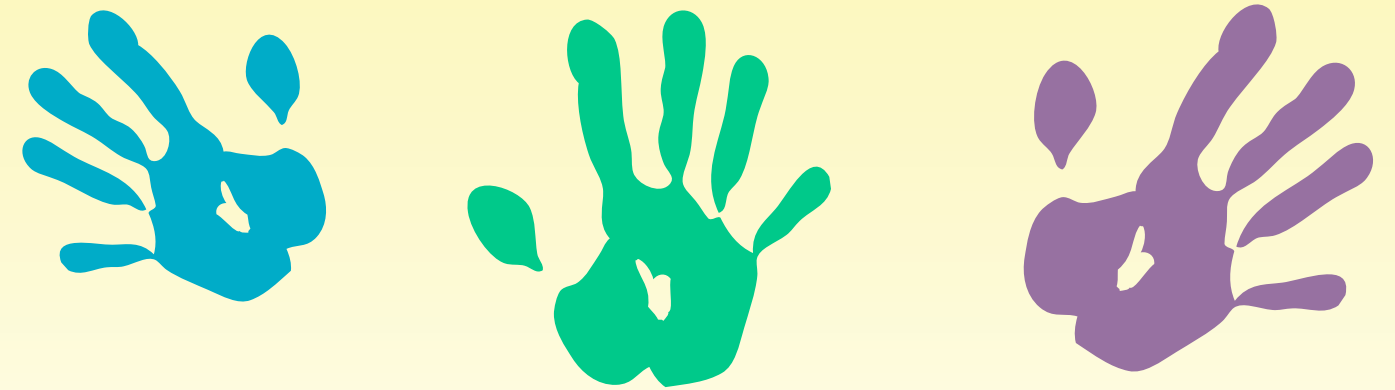

Conditions and Restrictions:

- This exclusive membership is only available to children of parents with Clubhouse, Squash, Tennis and or Golf memberships; and is not available to Social Members.
- With or without a Junior Membership, children under 10 years of age must be supervised by an adult at all times while on the club premises; unless they are participating in a Glenway-sponsored Junior program.
- Access to Glenway's fitness centre, adult locker rooms or golf course is not included in this membership. Access to the squash and tennis courts is free for Junior-Child members on a walk-on basis only, provided they are playing (and directly supervised) with an adult member who has paid their appropriate court fees-if applicable.

These sessions will be cancelled if no bookings are made by 8:00pm the preceding evening.

Cancellation Policy:

Parents/Guardians must cancel 4 hours prior to their booking time or a \$4.00/hr fee will apply.

* Child(ren) requiring care must be at least 6 months old during these sessions (evening & weekends).
Advanced booking is required for these times.

** Care is available to children between 6 weeks-6 months during indicated hours.
Advance booking is required for this age group. (No drop in privileges)

RATES

Free - if your child is a Glenway Junior-Child member (under 8 years of age). See back page of this brochure for more information on this membership, or consult one of our Club Services Representatives for details.

\$1.00 per 15 minutes, or \$4.00 per hour - if the child(ren) requiring care is/are dependents of an adult member in good standing.

\$2.00 per 15 minutes, or \$8.00 per hour - if the child(ren) requiring care is/are not dependents of an adult member in good standing.

Safety First

Glenway Country Club does not operate a licensed Day Care, and by law is not required to, however, we do pride ourselves in providing a fun, nurturing and safety first environment for your children; so you can enjoy Glenway's abundant facilities, services and programs with peace of mind.

1) A maximum of 8-10 children per caregiver (depending on their ages and care requirements) will be admitted; so please reserve in advance whenever possible.

2) As per the notice on our Glenway's babysitting schedule on page 2 of this brochure, children under 6 months of age are not able to visit during the weekend and 4:30pm to 9:00pm evening sessions.

3) If the current dedicated space for childcare becomes too busy, Glenway's care giving staff reserve the right to divide children into groups and use other venues on site.

4) Ontario law does not permit the parent/guardian to leave the Glenway premises/site while the child in their care is taking advantage of Glenway's babysitting services.

5) No children that are suffering from any communicable illnesses will be granted admission to



Glenway's babysitting services or facilities. We ask members to kindly respect this extremely important and critical policy, so that our staff is never required to enforce it.

Traffic Control

1) Prior to dropping their child(ren) off at the child care, parents/guardians are required to check in (with their children) at Glenway's main reception desk and complete a "Daily Registration Card & Voucher" in order to list: the child(ren) using the babysitting service that session, their time of entry, record any special care requirements and pay any applicable fees in advance. Upon completion of their child(ren)'s visit, the same card will be used to record the end of the session and if necessary, calculate any shortfalls with respect to fees paid in advance. In the event that there are outstanding fees due for extended care, parents/guardians will be required to return to the front desk in order to settle their account before picking up their children, prior to their departure from Glenway.

2) Care time calculations begin at point of club entry.

3) A maximum of 3 children per adult/guardian will be admitted per day to the child care.

4) Parents are encouraged to record the Glenway facilities,

programs and/or services they are intending to use while their child(ren) are in our care, so that we can locate them on the premises in the event of an emergency.

5) Please do not leave your children in Glenway's care until they are settled and relatively content with their new surroundings.

6) If the person picking up the children will be different than the adult who dropped them off, it is mandatory that the person checking in identify this individual by name on the Daily Registration Card & Voucher.



7) Crackers and juice may be left with staff for children's snacking; but please do not bring any foods or beverages containing peanut butter, nuts or their byproducts.

8) Caregivers are not responsible for feedings or diaper changes. In the event that a child is in need of either, parents will be asked to come to the day care in order to administer such care.

9) In order to ensure access and availability, we encourage all parents/guardians to reserve day care spots by telephone (ext 222) for their children in advance - even for sessions in which advanced reservations are not a prerequisite. (See the babysitting schedule for details.) Weekend and weekday afternoon and evening sessions, that have no reservations established by 8:00pm the previous day will be cancelled.

10) Parents are encouraged to record the Glenway facilities,

programs and/or services they are intending to use while their child(ren) are in our care, so that we can locate them on the premises in the event of an emergency.

11) Please do not leave your children in Glenway's care until they are settled and relatively content with their new surroundings.

12) If the person picking up the children will be different than the adult who dropped them off, it is mandatory that the person checking in identify this individual by name on the Daily Registration Card & Voucher.

13) Crackers and juice may be left with staff for children's snacking; but please do not bring any foods or beverages containing peanut butter, nuts or their byproducts.
